

Oklahoma Pinto Long Ear Futurity

The Long Ear Futurity will be held in conjunction with the Fall Bray & Neigh Show in September, 2025.

Eligibility

To be eligible to participate in the Oklahoma Pinto Long Ear Futurity

- 1. a weanling, yearling, 2-year old, or 3 or 4 year old long ear must be sired by a Jack who has been nominated into the Oklahoma Pinto Long Ear Futurity.
- 2. The weanling, yearling, 2-year old, 3-year old or 4- year old must be registered with a **nationally recognized** Long Ear Registry.
- 3. The Jack, Jenny or Mare must be registered with a Long Ear Association or a Horse Breed association.

Membership

To be eligible to participate in the Oklahoma Pinto Long Ear Futurity

1. Jack owners must be current OPtHA members. All owners and exhibitors of the long ear entries must be a current OPtHA member.

Classes Offered

The Oklahoma Pinto Long Ear Futurity classes will be offered as a separate class during the Oklahoma Pinto Fall Bray & Neigh Show in September. Futurity classes will be \$50 per class.

- 1. Mule Weanling/Yearling Halter (Open)
- 2. Donkey Weanling/Yearling Halter (Open)
- 3. Mule 2-Year Old Halter (Open)
- 4. Donkey 2-Year Old Halter (Open)
- 5. Mule 3-Year Old Western Pleasure (Open)
- 6. Donkey 3 & 4 Year Old Training Level Walk/Trot Western Pleasure (Open)

Enrolling the Jack

To participate in the Oklahoma Pinto Long Ear Futurity, the Jack owner pays the nomination fee of the Jack to make its foals eligible for that year's Futurity. Nominations are open from January 1 to May 31. A \$50.00 pentalty per month will be applied to the nomination fee for all Jacks not nominated by May 31, 2025. All Jack nomination fees will be distributed equally between the six Futurity Classes. (If a class is without entries, the money for that class will be equally distributed into the other 5 classes.)

- 1. January 01 May 31, 2025 \$250.00
- 2. June 01- June 30 , 2025 \$300.00
- 3. July 01 July 31, 2025 \$350.00
- 4. August 01- August 31, 2025 \$400.00
- 5. September 01 to Futurity , 2025 \$450.00

Jack enrollment can be paid in one lump sum or be paid out in monthly installments set up by the Oklahoma Pinto Treasurer. Anyone can pay the fee to nominate a Jack for foal eligibility.

Enrolling the Offspring

To participate in the Long Ear Futurity, you must enroll your foal (Mule or Donkey) into the Futurity program each year it is held.

- 1. January 01- May 31, 2025 \$50.00
- 2. June 01- August 31, 2025 \$75.00
- 3. September 01- Futurity \$100.00

All Futurity nominations will be applied to the total purse for payout in the respective class. The total purse will be an accumuliation of the Jack nominations combined with the Offspring nominations. Enrollment does not include the Class Entry Fee of \$50.00.

Payback of Purse

All monies will be divided between each class on the pay scale below.
